

## MINUTES

March 10, 2016

The Somerset Township Board of Supervisors met in Regular Session on Thursday, February 11, 2016, at 6:30 p.m. in the Somerset Township Municipal Building. Those present were:

Daniel H. Halverson Chairman; Donald K. Miller, Vice-Chairman; Tami L. Yutzzy, Township Secretary; and C. Gregory Frantz, Solicitor, were in attendance. Randy L. Beistel, Supervisor was excused from the meeting. Rebecca Herwig, a student of the Somerset Area High School was also in attendance. Matthew Toth, Daily American also attended the March meeting.

The Chairman, Mr. Halverson, called the meeting to order and lead the pledge to the flag.

Mr. Halverson then asked for any public comment. There was no public comment.

The Chairman asked for the reading of the Minutes of the previous meeting and the Financial Report for the previous month. Mrs. Yutzzy presented the board with the Minutes of the February 2016 meeting. She also presented the Board with the list of expenditure for the month of February. Mr. Halverson moved to approve all as presented. Mr. Miller seconded the motion. With all voting "yea," the motion carried and all stand approved as presented.

The board next established the dates for the annual "Spring Clean-Up Week." It was determined that the Township would hold sign-ups for the event April 25- April 29, 2016. During this time township residents may register for Spring Clean Up at the Somerset Township Municipal Building. It was established that the fee would stay at \$10 per household with a slight up charge for tires.

The board then discussed the "Free Bulky Waste" disposal that Somerset Township and Brothersvalley Township residents have the opportunity to take unwanted items to the Mostoller Landfill all year long free of charge. After a brief discussion the Chairman directed Mrs. Yutzzy to advertise the free service in the Daily American as a reminder to the residents that the option is available.

The next item of business before the Board was the authorization to solicit bids for stone, fuel, asphalt, and in-place seal coat. Mr. Halverson moved to make the authorization and Mr. Miller seconded the Motion. With all voting "yea" the motion carried and the authorization is so made.

The last order of business on the agenda was the Ordinance 16-02. This Ordinance requires that all individuals and community sewage disposal systems obtain a sewage permit for all real estate within Somerset Township boundaries. This Ordinance abolished the 10-acre exemption which was discussed at the February 2016 meeting. Mr. Halverson made a motion to enact the Ordinance No. 16-02 into law. Mr. Miller seconded the motion and with all voting "yea," the motion carried and the Ordinance stands enacted to become effective in five days.

The Chairman then called for any additional business before the Board. There was none.

With no other business before the Board the Chairman declared the meeting adjourned. There were no objections.
